**Public Comment** was called for. There were no comments.

A motion was made by D. Whitmoyer, seconded by D. DeMuro to **waive the reading of the minutes** from the July 18, 2022 Supervisor's Regular Meeting and **approve the minutes** from the July 18, 2022 Supervisors Regular Meeting as presented. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **waive the reading of the minutes** from the July 26, 2022 Joint Supervisor's & Planning Commission Special Meeting and **approve the minutes** from the July 26, 2022 Joint Supervisor's & Planning Commission Special Meeting as presented. Motion carried.

A motion was made by D. Whitmoyer, seconded by D. DeMuro to **receive the Planning Commission minutes** from the April 6, 2022 meeting as presented. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **receive the WBRA minutes** from the July 3, 2022 meeting as presented. Motion carried.

**Road Master Report** – Scratch paving was done the week of 8/08. Seal coating starting the week of 8/15 on various township roads (Swank, Bitler, Turkey Bottom & Egli Hill). Paving in Clarkstown starting in October. Sewer lateral from the park restrooms to the main line scheduled for October.

**Code Inspections Report** – June report received.

**Fire Company Report** – July report received.

A group was present to discuss "Downtown Muncy" which essentially encompasses the entire 17756 area code. They want to re-vitalize the community, utilizing grants and donations mainly. Would like to work with local governments and organizations. Mentioned a dog park, trails, river access, among other ideas.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **approve advertising open seats on the boards** (Planning Commission & Zoning Hearing Board). Motion carried.

Regarding the joint BOS & PC meeting, the planning commission solicitor has not heard from the supervisor's solicitor. He is supposed to be involved.

**L. Liggitt:** The stormwater waiver has not been received by the applicants to sign; he has been getting calls.

**C. Newcomer:** Have the new cameras been installed yet? Noticed there was some dumping at the donation bins.

How many permits were issued by codes on their last statement? She noticed properties within the township that should have land development and/or stormwater, that require attention from codes... Guthrie's, Kaiser Brothers, R&J Welch Firearms, Driveway's Express, Bob Shaffer.
