Road Master Report – Normal Spring maintenance. No build date on the new truck yet. Need the BOS decision regarding road projects. Original plan was to scratch pave bad spots and seal on top. Then there were 2 special meetings to discuss options. Now: 1. Reservoir Road: Proceed with original plan. 2. Old Glade Run Road: Work with Muncy Borough, do not move forward with original plan. 3. Glade Run Road: Prep the road this year and seal coat next year. 4. Berriman Hollow Road: Proceed with original plan. 5. Peter Gray Lane: Prep the road this year and seal coat next year. 6. Maple Lane: Base repair and double seal coat, proceed with original plan.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **receive the Code Inspections Report** for March 2023. Motion carried.

Fire Company Report – February 2023 report received. Building is coming along good. May 4th at 7pm at the Muncy Township Building is the next meeting for the 5 fire departments and municipalities. DCED will be there with a presentation.

A motion was made by D. Whitmoyer, seconded by D. DeMuro to **approve Harley Fry II's Stormwater Waiver Request**. Motion carried.

A discussion was had regarding the conditional use of the solar farm. Questions were brought up regarding fencing, power being generated, buffers, stormwater. The board decided to keep the determination of the sufficiency to meet the conditions that were set with the Board of Supervisors.

A motion was made by G. Phillips, seconded by D. Whitmoyer to send **a letter to the 9-11 Memorial Coalition, Inc.** regarding conducting their event within Muncy Creek Township on September 11, 2023, as part of the PennDOT permitting process. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **approve releasing the donation amount of \$500, as budgeted, to the Muncy Little League.** Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **add an item to the agenda**, to authorize grant writing for potential dog park. Motion carried.

A motion was made by D. Whitmoyer, seconded by D. DeMuro to authorize grant writing for the potential dog park. Motion carried.
