A motion was made by G. Phillips, seconded by D. DeMuro to **approve the MCTSA Transfer Agreement to WBRA**. D. Whitmoyer abstained. Motion carried.

This will be ratified at the next Board of Supervisors meeting; this is allowing pay to be utilized until then. Motion carried.
