

A Muncy Creek Township Supervisors Regular Meeting was held at the Township building on Monday, December 18, 2023, at 7:00 p.m. The meeting was called to order by chairman, Gary Phillips followed by the pledge of allegiance. The following were present:

Public Comment was called for. Harley Fry had a question regarding Item# 12 on the agenda (Approve 2024 Proposed Budget and Tax Rate), are taxes being raised? No.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **waive the reading of the minutes** from the November 20, 2023 Supervisor's Regular Meeting and **approve the minutes** from the November 20, 2023 Supervisor's Regular Meeting as presented. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to receive the **Sewer Authority minutes** from the October 25, 2023 meeting as presented. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to receive the **WBRA minutes** from the November 8, 2023 meetings as presented. Motion carried.

Leon Liggitt gave update on behalf of WBRA, MCTSA closing will be before the end of the year.

Road Master Report – Pipe replacement starting tomorrow on Swank Hill Road. Will last about two weeks. Laser level has been ordered at the request of Supervisor Phillips.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **receive the Code Inspections Report** for November 2023. Motion carried.

Fire Company Report – November 2023 report received. Scott Delany informed the board that the fire company received a \$50,000 grant from the Margaret Waldron Memorial Fund, \$10,000 a year for 5 years from Journey Bank and \$5,000 from Service First Federal Credit Union. The community has been very supportive of MAVFC, still need members though.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **approve the Fire Service Agreement** between Muncy Creek Township and MAVFC. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **approve the 2024 Proposed Budget and Tax Rate (resolution 23-205 & 23-206)**. Motion carried.

Chairman Phillips motioned to **vote regarding the conditional use hearing held on November 20, 2023. D. Whitmoyer voted no, G. Phillips voted no.** Motion carried. A motion was made by G. Phillips, seconded by D. Whitmoyer to **accept the findings and facts of law.** Summarized by Solicitor Stephen Hartley. Motion carried.
