Organizational & Regular Meeting

The organizational and regular meetings of the Muncy Creek Township auditors for the year 2023 was opened at 7:05 pm on Tuesday, January 4, 2023, in the Muncy Creek Twp. building. Acting chairman, Christopher Ebner, called the meeting to order.

A motion was made by Eric Newcomer, seconded by Keith Fry to appoint Chris Ebner as the temporary chairman. Motion carried

A motion was made by Chris Ebner, seconded by Keith Fry, to set a wage of \$15.30 per hour for Supervisors Gary Phillips, Dan Whitmoyer, and Dan Demuro as temporary part time road workers for the year 2023. Motion carried.

A motion was made by Chris Ebner, seconded by Keith Fry, to draft a letter from the auditors to the Board of Supervisors requesting that the 2022 audit, completed by Richard C. Lowe, P.C., be released to all three auditors no later than May 1, 2023. Additionally, the auditors request that the Board of Supervisors appoint a CPA to perform the 2023 audit, per section 917 of the Second-Class Township Code, and that an agreement with the CPA of their choosing be provided to all three auditors no later than April 30, 2023. Motion carried. Secretary Eric Newcomer will draft such a letter to be delivered to the supervisors via email and USPS.
