Victor Marquardt, Township Zoning Officer, gave info from the building code standpoint. He said a certificate of occupancy is needed. Mr. Leidhecker asked what could be done in between receiving the will serve letter and his connection to the public system? Could a pump agreement/schedule be submitted to the township? Supervisor Newcomer stated that all information would need to be submitted in writing. Cindy Newcomer asked if his property is in the 537-plan service area? Would a revision be needed to the 537-plan to accommodate?

Township property at 170 West Water Street. Supervisor Newcomer has spoken with the President of Muncy Garden Club regarding working jointly to fix up the property on Water Street.
