- Conditional Use Application for Today Farm. Applicant presented letters of support and narrative for property. Asking for a favorable recommendation from the planning commission to the board of L. Liggitt inquired about "non-ag supervisors. events". The applicant stated they could be events such as 4th Friday, Music on the farm, kind of ag adjacent, community and family involvement. H. Fry questioned alcohol sales and M. Kreisher asked about traffic turning left onto Water Street from the farm and how that may impact things. What about a traffic study, traffic light, traffic control for events? Applicant did mention he may have a deeded right of way onto Mechanic Street. A motion was made by L. Liggitt, seconded by H.
