MUNCY CREEK TOWNSHIP SUPERVISORS REGULAR MEETING

A Muncy Creek Township Supervisors Regular Meeting was held at the Township building on Monday, April 22, 2024, at 7:11 p.m. The meeting was called to order by chairman, Gary Phillips followed by the pledge of allegiance. The following were present:

Public Comment was called for. There were no comments.

A motion was made by G. Phillips, seconded by Dan Whitmoyer to **waive the reading of the minutes** from the March 18, 2024 Supervisor's Regular Meeting and **approve the minutes** from the March 18, 2024 Supervisors Regular Meeting as presented. Supervisor Newcomer noted that he would like an addition to the March 18, 2024 minutes stating that it was recommended by the township solicitor to not approve the work that WBRA does regarding section 5.v. in the agreement between MCT and WBRA. Also, an addition to the March 18, 2024 minutes stating that the Today Farm Sewage Module did need to go to the Planning Commission. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to receive the Planning Commission minutes from the March 6, 2024 meeting as presented. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **receive the WBRA minutes** from the March 13, 2024 meeting as presented. Motion carried.

Road Master Report – Dirt road work, ditches cleaned, roads graded, pipes cleaned.

Discussion was had regarding new trucks. One Freightliner to replace both Sterlings. Place 1 of the Sterlings on Municibid now, once the Freightliner comes in, place the other Sterling on Municibid. Both Sterlings are 2006's and probably have around 15-16,000 miles on them. Would also like a work truck to replace the 2017 F350. The new 600 on order will replace the 2015 the township currently has. The board would like the time frame for the chassis, estimated value for vehicles the township is looking to sell, can a vehicle be pre-ordered or does it have to be a budgeted item first? Add back to the agenda for May's meeting after research is done.

A motion was made by G. Phillips, seconded by D. Whitmoyer to place one Sterling on Municibid (whichever one the Roadmaster decides).

The Code Inspections Report for March 2024 has been received.

Fire Company Report – **The monthly report** for March 2024 has been received. Discussion regarding fire police for events. There is already a resolution in place.

Ratify Resolution 24-212 Today Farm Component 2 Sewage Module. The board had concerns that the Component II was done backwards. The solicitor was not present to explain the situation. A motion was made by G. Phillips, seconded by D. Whitmoyer to table this until the next meeting. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to appoint Part Time Park Employees (to mow grass at Kiess Park), Gary Phillips, Eric Newcomer and Dan Whitmoyer at the rate set by the Township Auditors (\$12.00/hour) and Lori Brown at \$12.00/hour. Motion carried.

A motion was made by E. Newcomer, seconded by D. Whitmoyer to **approve the 9-11 Memorial Coalition Ride Letter** as resubmitted by M. Wiley. Motion carried.

A motion was made by E. Newcomer, seconded by D. Whitmoyer to **approve the Lycoming County Veterans Day Parade Letter** as resubmitted by M. Wiley. Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to approve the donation request of the Muncy Community Action Program (CAP) of \$500 (as budgeted). Motion carried.

A motion was made by G. Phillips, seconded by D. Whitmoyer to **approve the Three+one Agreement**, with the officials as Eric Newcomer and Cari Buck. Motion carried. Note, CPA Rick Lowe is okay with the agreement, no response from Mike Wiley regarding the agreement.

Bids were opened for the building renovations. Bids were received from Martins Construction, JB Gibbons & KC Construction.

A motion was made by E. Newcomer, seconded by G. Phillips to receive the 3 bids (one appeared to be unsealed) and get a legal opinion on the bids received, validate the bids and announce the decision at the next meeting. Motion carried.

Public comments:

B. Green: What about Charlie mowing?

Meeting was **adjourned** by Supervisor Phillips at approximately 8:12 p.m. Meeting was quickly reconvened a moment later for an additional public comment that was missed.

B. Adema, Sr.: Speeding on South Main Street/Susquehanna Trail is a problem. Resident has spoken with the State Police but they are undermanned. Could Muncy Borough Police help? Jake brakes are an issue also. The board will look into it and add the topic back to the next meeting agenda.
